KEY TRENDS

Here is a snapshot of the key trends that we're seeing in the resources collected.

This month the Clearing House search focused on **vaccine deployment strategies at the global, regional and national level**. A total of **18 articles** that fit the inclusion criteria of involving the private sector in vaccine deployment efforts were collected over a span of 2 weeks. Of these 18 resources, majority articles addressed the **service delivery** function of the health system (86%), followed by **resource generation** (57%), **governance** (29%) and lastly, **financing** (7%). **Importantly, the literature exposed a gap in research related to vaccine deployment experiences in country and rather covered guidance and plans for vaccine deployment.**

[Jordan's successful experience in COVID-19 vaccine roll-out](#) provides lessons for other low- and middle-income countries. The implementation of the National Deployment

and Vaccination Plan (NDVP) relied on public-private collaborations such as the multi-sectorial National Coordinating Committee to add more entities to achieve the goal of vaccinating over 80% of the population, including refugees and migrants.
