KEY TRENDS

Here is a snapshot of the key trends that we're seeing in the resources collected.

This month the Clearing House search focused on COVID-19 response efforts in the Eastern Mediterranean Region with a specific focus on [Egypt, Iran, Iraq, and Morocco](#). A total of **36 articles** that fit the inclusion criteria were collected over a span of 2 weeks. Of these 36 resources, **majority of the articles related to the general response to COVID-19** (67%) by the private sector, followed by a specific focus on vaccines (33%), diagnostics (19%), therapeutics (17%) and PPE (17%). In terms of health system function, a significant majority of the articles pertained to **service delivery** (83%), followed by **governance** (39%), resource generation (14%) and lastly, financing (7%).

Morocco



The Oxford Business Group's "COVID-19 Response Report" highlights [5 important lessons to take away from Morocco's COVID-19 response strategy](#), including an emphasis on public-private partnerships.

The report considers that the public and private sectors worked well together to overcome unprecedented odds in the fight against COVID-19 and makes recommendations for further strengthening the engagement with the private sector in health.

[Public-private-people partnerships have contributed significantly to the Iran COVID-19 response strategy.](#)

This study collected evidence of PPPs pertaining to national COVID-19 response efforts and found that private sector participation was enhanced through associations or groups, such as religious groups and non-governmental organizations. The study concludes that enhanced social capital, institutionalization and government infrastructures could improve PPPs.
