Pilot phase has been FINALIZED Progression Pathway on Governance of Mixed Health Systems

The Progression Pathway is a tool that was developed to facilitate the design a tailored roadmap for private sector engagement by supporting of governments and national health authorities in identifying the governance arrangements and capacities needed to deliver better health outcomes in their context. The tool helps countries position themselves across four progress levels for each of the governance behaviors outlined in WHO strategy on Engaging the private health service delivery sector through governance in mixed health systems

# **Tool:** Engaging the private sector in delivering quality MNCH services: a step-by-step workbook to inform analysis and policy dialogue



We developed <u>a workbook</u> that aims to assist various stakeholders in engaging with the private sector on delivery of quality maternal, newborn and child health (MNCH) services in lower- and middle-income countries. The workbook suggests an iterative approach that is supported by various guiding tools for the process.

Recognizing the importance of private sector engagement in the WHO Eastern Mediterranean region, the WHO Strategy report on <u>Engaging the</u> private health service delivery sector through governance in mixed health systems has been translated into <u>Arabic.</u>

# **Engagement with the private sector in the Eastern Mediterranean**

We have added an assessment series featuring regional syntheses on the <u>operational</u> <u>environment of the private health sector</u>, its role in the <u>provision of essential health</u> <u>services</u> and <u>COVID response</u> in the Eastern Mediterranean Region. The series also includes specific reports on <u>Jordan</u>, <u>Lebanon</u>, <u>Oman</u>, <u>Qatar</u>, <u>Iraq</u>, <u>Occupied Palestinian Territories</u>, <u>Somalia</u> and <u>Djibouti</u>.

#### **Brief:** Governance of the private sector in fragile, conflictaffected and vulnerable settings

We developed <u>a brief</u> that focuses on the wide terrain of governance interaction and the effects this has on health service delivery and access for conflict affected populations. It outlines three strategies for policy response and associated tools. Country cases reviewed for the brief have focused on well-known FCVs and those suffering from a confluence of crises related to security, humanitarian, political, and economic factors.

#### Brief: Governance of dual practice in the public and private sectors

We developed <u>a brief</u> that delves into the available literature on dual practice, the governance challenges posed by it and the potential policy options and governance tools that can address those challenges.

#### **Brief:** Data for governance of the private sector in health

This brief explores constraints to data capture and management within health systems and its use for decision making with specific focus on the governance of the contribution of the private sector in health to public health outcomes.

On October 1<sup>st</sup>, we hosted a consultative workshop in Islamabad, Pakistan as part of a study that aims to identify the types of data and information currently collected by the government, and how this data is utilized for governing the private health sector.
