The Country Connector hosted a Data Working Group meeting with members this month, to review the study Protocol on Using Data to Drive Governance, which seeks to identify what data and information is currently being collected by governments and how this is used for governance of the private sector in health. The meeting also gathered feedback on the country piloting approach for implementation of the study protocol and on a key informant sampling matrix. Country case studies and a comparative insights synthesis will be the key outputs of the study and inform the development of a WHO Technical Product in 2024.
